
Transition your Workouts with the Seasons:

Recipe of the Month | September 2022

Frosted Pumpkin Donuts for a Sweet Fall Treat!

Donuts Ingredients

VANDYK MORTGAGE

Frosting Ingredients

2 large eggs 1 cup sugar 2 tablespoons butter, softened 1 cup canned pumpkin 1 tablespoon lemon juice 4-1/2 cups all-purpose flour 2 teaspoons baking powder 1 teaspoon baking soda 1/2 teaspoon salt 1/2 teaspoon salt 1/2 teaspoon ground cinnamon 1/2 teaspoon ground nutmeg 1 cup evaporated milk Oil for deep-fat frying



3 cups confectioners' sugar 2 to 3 tablespoons orange juice 1 tablespoon evaporated milk 1 teaspoon grated orange zest



- 1. In a large bowl, beat eggs, sugar and butter until smooth. Beat in pumpkin and lemon juice. Combine flour, baking powder, baking soda, salt, cinnamon, and nutmeg; gradually add to pumpkin mixture alternately with milk. Cover and refrigerate for 2 hours.
- 2. Turn onto a lightly floured surface; knead 5-6 times. Roll to 3/8-in. thickness. Cut with a lightly floured 2-1/2-in. doughnut cutter.
- 3. In an electric skillet or deep-fat fryer, heat oil to 375°. Fry, a few at a time, until golden brown on both sides. Drain on paper towels.
 Combine frosting ingredients, dip tops of warm doughnuts into frosting.
